Applications that do not meet these eligibility requirements will not be progressed.

### Application Process

- Applications must be submitted by an authorised senior representative of the business.
- Once submitted, applications **cannot be amended**.
- Westpac reserves the right to request further information or conduct interviews as part of the assessment process.
- Shortlisted applicants may be required to provide supporting information, including financial documentation such as profit and loss statements and tax records.
- Shortlisted applicants may be required to consent to a police check.
